2. The above grant is subject to the following conditions namely:-

- (i) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme.
- (ii) Provide the State Share in the sharing pattern of 75:25 between the Central Government and the State Government.
- (iii) Distribute/allocate in any of the components/sub-components of SJSRY. However, the achievement of physical targets must be kept in view while allocating funds under the different components/sub-components.
- (iv) Furnish the Utilization Certificates for the Grant released in the early years for the SJSRY.
- (v) Furnish Quarterly Progress Report for the Scheme in time.

3. Certified that no Utilization Certificate is pending in respect of the States mentioned in the Sanction Order as per requirement.

4. The expenditure involved is debitable as under Major Head – 3601 – Grants-in-aid to State Govts.-04 – Grants for Centrally Sponsored Plan Schemes (Sub-Major Head) – 04.435- Other General Economic Services - Urban Oriented Employment Programme (Minor Head)-01 - Swarna Jayanti Shahari Rozgar Yojana - 01.10 – Assistance to State Level Agencies – 01.10.31 – Grants-in-aid (PLAN) under Demand N0.55 – Ministry of Housing & Urban Poverty Alleviation for the year 2007-08.

5. The Drawing and Disbursing Officer of the Ministry of Urban Development will prepare bill and the Drafts will be issued in favour of the payee as mentioned in **Para 1** above.
